## PUBLISHED, COMMISSIONED ILLUSTRATION WORK

Eligibility for General Membership requires that you be a freelance illustrator who has produced either:

- Five (5) published, commissioned illustrations in a one (1) year period
- or
- Eight (8) published, commissioned illustrations in a two (2) year period

in one or more of the following areas:

**Periodicals:** Periodicals of general circulation readily available on newsstands regionally or nationwide such as a regional publication, major trade publication, major consumer publication, or major Internet magazine.

**Books:** Jacket or interior illustrations published in a book by an established American publisher.

**Advertising , Promotional and Pr oduct:** Illustrations for advertisements, promotions, collateral pieces, merchandise or in-house publications for a client producing a nationally or regionally distributed product or service.

**Animation, Film and TV: Illustrations** created for or distributed by an established American film studio or appearing nationally on television (network or cable).
